



# Culture X AI 2024-2025: Culture and Future Mode Call for International Young Fashion Talent

With the support from our lead sponsor, Cultural and Creative Industries Development Agency (CCIDA) of the Government of the Hong Kong Special Administrative Region, Laboratory for Artificial Intelligence in Design (AiDLab) is proud to present Culture X AI 2024-2025: Call for International Young Fashion Talent. AiDLab is the region's first research platform that focuses on the integration of Artificial Intelligence (AI) with design. It was jointly established by The Hong Kong Polytechnic University (PolyU) and the Royal College of Art (RCA) in the UK.

Culture X Al 2024-2025: Culture and Future Mode is now calling for international young fashion talent to join us on our innovation exploration with Artificial Intelligence-based interactive Design Assistant for Fashion (AiDA). The AiDA development team will mentor 10 selected international young fashion talent, sharing the know-how of AiDA and guide the young talent through their creative journey.

Each selected young fashion talent will create a 4-outfit collection with a theme "Culture" using AiDA with full technical support from our team and a chance showcasing their collections next March in the Hong Kong Palace Museum. They will be entitled for a production cost subsidy and return trip tickets\* from Hong Kong to attend the final showcase in-person.

# **Eligibility**

The Call for International Young Fashion Talent only accepts applications from individuals. Applicants must be current students or graduates of tertiary education<sup>1</sup> institute majoring in fashion design or design within the last 5 academic years<sup>2</sup> at the time of application.

- Tertiary education refers to diploma, undergraduate, postgraduate or research programme.
- Graduated from academic years 2018-2019, 2019-2020, 2020-2021, 2021-2022, 2022-2023.

## Selected Young Fashion Talent Receives:

- 1. A chance to show your collection in the *Culture X AI International Fashion Show* at the Hong Kong Palace Museum
- 2. Production subsidy up to HK \$40,000 for a 4-outfit fashion collection
- 3. Mentorship programme with AiDA development team
- 4. Free access to AiDA system with full technical supports from the development team within the programme period
- 5. 1 economy class return-trip ticket to Hong Kong with 3-night accommodation (for selected International and Mainland Young Fashion Talent only, details to be announced)

# Submission Requirements and Deadline

The application and the supporting documents should be submitted online via the application system:

- 1. Education Credentials
  - a) A scanned copy of education credentials shall be uploaded to the registration system to prove the eligibility of the applicant.
  - b) The file should be uploaded as a .jpg/ .jpeg or .pdf and the file size should not exceed 10MB.
- 2. Portfolio w/ Design Statement
  - a) A portfolio showing 4 previous fashion design works of the applicant accompanied by the following items,
    - Mood board
    - ii. Colour board
    - iii. Material board
    - Fashion development sketches iv.
    - Illustrations with production drawings ٧.
  - b) A design statement with a maximum of 300 words should also be submitted along with the portfolio to elaborate the creative ethos and collection concept.
  - c) The portfolio should be uploaded as a .pdf with a maximum of 20 pages. The file size should not exceed 30MB.
  - d) The portfolio should be named "First Name LASTNAME portfolio.pdf" (e.g. Peter\_CHAN\_portfolio.pdf).
- 3. Applications with incomplete information will **NOT** be considered.
- 4. **NO late submissions** will be accepted under any circumstances. All applications should be submitted on or before 7 September 2024 (Saturday) by 11:59PM (HKT/ GMT+8)/ 11:59AM (EST time)/ 4:59PM (BST time).

# Judging Criteria

Selection Criteria	Weighting	Focus
Creativity and originality	50%	To assess the applicant's approach for concept development and the ability to think creatively and demonstrate originality in their design.
Innovative use of materials and colours	30%	To assess the applicant's creative abilities and approaches to utilize different materials and colour scheme.
Overall presentation of portfolio	20%	The applicants should be able to present adequate knowledge and skill for fashion design in their portfolio.
